Summary of Testimony

- The aforementioned received several lessons in the [Salafi] ideology with multiple people that are of the deviant ideology. [redacted] used to give them the lessons, and the lessons with [redacted] back in 2013 continued for 5 months, following which [redacted] began working in Hamas and left the lessons and the deviant ideology. The people attending the lessons were [redacted]
- The aforementioned received the ideological lessons with [redacted] and [redacted] attended the lessons with the aforementioned.



- The aforementioned obtained publications of the Islamic State when he was at [REDACTED]'s apartment, and when he was at his apartment, at his house (sic), via the Akhbar al-Muslimin website that belongs to the Islamic State organization.
- [REDACTED] talked with the aforementioned about fighting with ISIS in Sinai and motivated them to fight with it when obtaining the publications.
- The aforementioned testified that 3 years ago he asked [REDACTED] to take him to Sinai, and he testified that 3 months ago he asked [REDACTED] again and the latter answered him 'may our Lord make it easy.'

Results of the Interrogation

- He finished studying in high school at the [REDACTED] Secondary School in [REDACTED] in 2012.
 - The aforementioned finished a technical diploma in audiology in 2015 from the University College.
 - He is currently studying for a B.A. in Administration at the Gaza University, and he is currently in his first year.
 - The aforementioned works in the Save the Children association as maintenance in Gaza [City], next to the Islamic University offices. Its [Save the Children's] director is called [REDACTED], who is the aforementioned's uncle.
 - The aforementioned worked in the Palestinian Islamic Jihad (PIJ) in 2007, and worked in the military wing for 5 months, and after that he left the work following the martyrdom of his cousin [REDACTED], who was his [PIJ] direct commander.
- ☒ **The case in details:**
- He testified that from 2009 he worked in the Ibn Baz association [a Salafi association] and met several people, among them [REDACTED] all of whom live in Al-Maghazi.
 - He testified that he received several lessons in the Ibn Baz association. The person who gave him the lessons was [REDACTED] and he used to go to Da'wa [preaching and recruiting] tours.
 - He testified that he continued working in the Ibn Baz association for about 3 years.
 - He testified that he met [REDACTED] during his work in the deviant ideology, and that [REDACTED] offered him to attend Sharia lessons at his apartment, and the aforementioned agreed.
 - He testified that in 2013 he attended Sharia lessons at [REDACTED]'s apartment, and the lessons were in ideology and Islamic law.
 - He testified that among the people who attended the lessons were [REDACTED], all of whom live in Al-Maghazi.
 - He testified that the meetings at [REDACTED]'s apartment continued for about 5 months. After that [REDACTED] left the lessons and worked in Hamas.



- He testified that [REDACTED] stopped attending [the lessons] after [REDACTED] left, but he [REDACTED] attended irregularly, twice, and after that he quit.
- He testified that [REDACTED] started giving them lessons, and the people who attended are [REDACTED] and the aforementioned.
- He testified that he watched publications of the Islamic State organization when he was at [REDACTED].
- He testified that he followed up on ISIS publications via the Akhbar al-Muslimin website that is for videos of the Islamic State organization and via YouTube.
- He testified that when he obtained Islamic State publications at [REDACTED]'s apartment, [REDACTED] used to talk with them about fighting in Sinai [with ISIS], and he [REDACTED] supported the fighting and intended to leave in order to fight with them, accompanied by the aforementioned and [REDACTED]. This was three years ago.
- He testified that [REDACTED] continued to give them lessons until the end of 2018, and after that he did not receive any lessons since [REDACTED] was occupied with the Doghmush [clan] tyre shops. He gathered with them for meetings with no lessons, and the last meeting with [REDACTED] was days before he was imprisoned, at the aforementioned's apartment, at sunset, while the aforementioned was alone, and his brother [REDACTED], who works in the Palestinian Islamic Jihad was present. The meeting continued until evening.
- He testified that after [REDACTED] was imprisoned by the Interior [Security Mechanism], about two months ago, the aforementioned did not receive any lessons, and he met [REDACTED] twice at his apartment.
- He testified that he asked his brother [REDACTED] who works in the Palestinian Islamic Jihad to return and [again] work with the Palestinian Islamic Jihad. This was about 3 months ago.
- He testified that he currently ceased his relationship with people of the deviant ideology due to his work in a societal association (Save the Children), which he intends to keep [the job], and he is devoted to his work.
- The aforementioned testified that 3 years ago he asked [REDACTED] to take him to Sinai, and he testified that 3 months ago he asked [REDACTED] again and the latter answered him 'may our Lord make it easy.'

Recommendations

- It is required to summon [REDACTED] for interrogation.
- It is required to monitor the aforementioned in the area of his residence.
- It is required to release the aforementioned from custody.
