OF THE THIRTEENTH JUDICIAL CIRCUIT IN AND FOR THE COUNTY OF HILLSBOROUGH, CHARGES THAT:

COUNT ONE

JOSE PAGAN JR, between the 8th day of December, 2025, and the 31st day of January, 2026, inclusive in
the County of Hillsborough and State of Florida, did send, post, or transmit, or procure the sending,
posting, or transmission of, a writing or other record, including an electronic record, in such a manner in
which it may be viewed by a person, that such writing or record is a threat to conduct a mass shooting
and/or an act of terrorism.

COUNT TWO

JOSE PAGAN JR, between the 8th day of December, 2025, and the 31st day of January, 2026, inclusive in the County of Hillsborough and State of Florida, did attempt to willfully and unlawfully, or while in the commission of any felony, by fire or explosion, damage or cause to be damaged a structure to-wit: A church, owned by UNITED METHODIST CHURCH GROUP AND/OR REVEREND SARAH B. MILLER AND/OR JEANIE COFER or another.

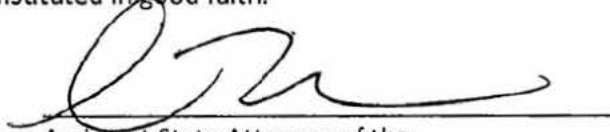

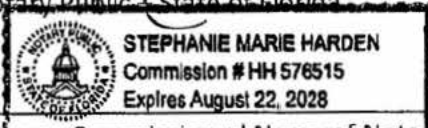

The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
On January 31, 2026, Detective House #223052 obtained a search warrant for 14341 Alistar Manor Drive, Wimauma, FL regarding the offenses of the possession of child pornography, transmission of child pornography by electronic device, and the written or electronic threat to conduct a mass shooting or act of terrorism. The search warrant was to search and seize electronic devices capable of storing or transmitting electronic devices from the home; firearms; ammunition; magazines; and clothing unique to the investigation described in the search warrant document. The search warrant was executed on the same date.

During the execution of the search warrant, your Affiant came into contact with Jose Pagan Jr (date of birth December 20, 1977) and Jose Pagan Sr (date of birth November 30, 2011). Jose Pagan Sr provided consent to interview Jose Pagan Jr. Jose Pagan Sr was present during the interview. The interview was audio recorded. Your Affiant qualified Jose Pagan Jr via the Ramirez factors and your Affiant informed Jose Pagan Jr of his Miranda warnings via an HCSO Miranda warnings card. Each warning was explained in detailed to Jose Pagan Jr. Jose Pagan Jr made a recorded post-Miranda confession.

During the interview, Jose Pagan Jr identified the suspect's Discord account information as being his and that he utilized the accounts on his electronic devices. He confirmed he would have child pornography on his iPad tablet. He confirmed he has received child pornography from other people and has sent out child pornography to other people. He is aroused when he views child pornography and he has masturbated to it. He provided the name for one of the videos as [REDACTED]

During a live preview of Jose Pagan Jr's iPad tablet and his cellphone video files of child pornography were located on the device. A total of 14 child victims were observed in the video files. Per FSS 827.071, each child victim observed is a separated offense of the possession of child pornography. Jose Pagan Jr had compilation video files of child pornography.

The files of child pornography depicted the Sadio masochistic abuse of child victims while being sexually battered. The videos depicted child victims being bound with rope and hung while being sexually battered. Acts of sexual battered included oral and [REDACTED]. The child victims were primarily [REDACTED] years of age being sexually battered.

Detective House determined the child victims to be minors due to their childlike features including the small statures, small torso, small limb size, [REDACTED] lack of pubic hair, [REDACTED] and cherubic faces. Some child victims were clearly [REDACTED]

The files qualify as enhancement per FSS 775.0847(2) due to the defendant possessing ten or more instances of child pornography and the defendant possessing video files of child pornography, sexual battery on child victims, the Sadio masochistic abuse of child victims, and child victims [REDACTED] years of age.

On 01/25/2026, at 1543 hours EST (2043 hours UTC) defendant Jose Pagan, JR utilizing the screenname "J3st3r_ov_insurr3ect0n" on the social media platform Telegram began posting the following messages. The above screenname was attributed to the defendant via confirmation of the originating IP address (47.201.113.193). Through investigative means, the IP address was found to belong to the defendant's residence of 14341 Alistar Manor Dr Wimauma, FL 33598 within Hillsborough County, FL.

At 1543 hours, the defendant posted, "where i live there are two churches right next to eachother, 5 minute drive down there, two congregations, right after christmas" immediately followed by "oh the GLORY!" and a photograph depicting a black assault-style rifle, black shotgun, and several boxes of ammunition displayed lying on a tan colored carpet.

At 1544 hours, the phrase "I was in TCC [True Crime Community] since I was 12 but shooting up a school doesnt seem interesting to me" followed immediately by "a church is a way better target".

At 1546 hours EST (2046 hours UTC), defendant Jose Pagan, JR posted "i agree, but a satanist attacking a church, it sends a message" immediately followed by "a message that WE have no forgotten what they did to us" and "a message that their crimes in europe have not been forgotten"

On 12/31/2025, 1444 hours EST (1744 hours UTC), defendant Jose Pagan, JR posted the statement "i got a rare look into my dad's guncase" along with a photograph of a black gun safe in the open position, with the two above described firearms leaning against it and several boxes of ammunition within the safe.

On 12/11/2025, the user posted an image of a black in color boiler suit with a custom "NLM" (reference to the nihilistic violent extremist group "No Lives Matter") pin added to it with a skull mask above.

On 12/11/2025, the user shared an image of a self-made t-shirt that says "NLM" and "Tempel ov Hate" (the name of the Tempel ov Blood nexion whose Telegram chat the user is active in).

The Telegram profile image features bullet cartridges arranged in the symbol for Liber 333, a foundational text for the Satanic Neo-Nazi group Tempel ov Blood which advocates for violence to achieve spiritual enlightenment.

The above text was willfully and intentionally uploaded to Telegram, by the defendant, expressing his intention to commit a mass shooting at two churches located near his residence. Additionally, the defendant willfully and intentionally uploaded photographs of clothing, firearms and ammunition indicating he had procured and identified the means to enact the threat expressed. During a post-miranda interview with the defendant, he confirmed to be the owner of the above listed Telegram account. Jose Pagan Jr verbally identified himself to me.

Pursuant to Florida Statute §92.525 and under penalties of perjury, I declare that I have read the foregoing document and the facts stated in it are true to the best of my knowledge. For Notices to Appear, I also certify that a complete list of witnesses and evidence known to me is attached.

The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
On January 31, 2026, your Affiant obtained a search warrant for 14341 Alistar Manor Drive, Wimauma, FL regarding the offenses of the possession of child pornography, transmission of child pornography by electronic device, and the written or electronic threat to conduct a mass shooting or act of terrorism. The search warrant was to search and seize electronic devices capable of storing or transmitting electronic devices from the home; firearms; ammunition; magazines; and clothing unique to the investigation described in the search warrant document. The search warrant was executed on the same date.

During the execution of the search warrant, your Affiant came into contact with Jose Pagan Sr (date of birth December 20, 1977) and Jose Pagan Jr (date of birth November 30, 2011). Jose Pagan Sr provided consent to interview Jose Pagan Jr. Jose Pagan Sr was present during the interview. The interview was audio recorded. Your Affiant qualified Jose Pagan Jr via the Ramirez factors and your Affiant informed Jose Pagan Jr of his Miranda warnings via an HCSO Miranda warnings card. Each warning was explained in detailed to Jose Pagan Jr. Jose Pagan Jr made a recorded post-Miranda confession.

During the interview, Jose Pagan Jr identified the suspect's Discord account information as being his and that he utilized the accounts on his electronic devices. He confirmed he would have child pornography on his iPad tablet. He confirmed he has received child pornography from other people and has sent out child pornography to other people. He is aroused when he views child pornography and he has masturbated to it. He provided the name for one of the videos as [REDACTED]

During a live preview of Jose Pagan Jr's iPad tablet and his cellphone video files of child pornography were located on the device. A total of 14 child victims were observed in the video files. Per FSS 827.071, each child victim observed is a separated offense of the possession of child pornography. Jose Pagan Jr had compilation video files of child pornography. Ten instances of child pornography were located on Jose Pagan Jr's cellphone and four instances of child pornography were located on his tablet.

The files of child pornography depicted the sadomasochistic abuse of child victims while being sexually battered. The videos depicted child victims being bound with rope and hung while being sexually battered. Acts of sexual battered included oral and [REDACTED]. The child victims were primarily [REDACTED] years of age being sexually battered.

Your Affiant determined the child victims to be minors due to their childlike features including the small statures, small torso, small limb size, [REDACTED] lack of pubic hair, [REDACTED] and cherubic faces. Some child victims were clearly [REDACTED]

The files qualify as enhancement per FSS 775.0847(2) due to the defendant possessing ten or more instances of child pornography and the defendant possessing video files of child pornography, sexual battery on child victims, the sadomasochistic abuse of child victims, and child victims [REDACTED] years of age.

At the conclusion of the search Jose Pagan Jr was arrested for 14 counts of possession of child pornography ten or more images and content of images, 1 count of in state transmission of child pornography by electronic device, 2 counts of unlawful use of two way communications device, and 1 count of written or electronic threat to conduct mass shooting or act of terrorism.

Jose Pagan Jr's electronic devices were forensically analyzed offsite back at HCSO's Internet Predator Unit's Office. During your Affiant's review of the forensic devices your Affiant located additional offenses.

Your affiant reviewed the forensic report for Exhibit 3 which was identified as Jose Pagan Jr's cellphone.

Your Affiant reviewed the media files on the device. Your Affiant located a total of 24 instances of child pornography on the cellphone. Of the files of child pornography, I located three video files and fifteen image files of child pornography. Some files depicted more than one child victim. Per FSS 827.071, each child victim is a separated offense of possession of child pornography. The files had creation dates / last accessed dates ranging from December 20, 2024, to January 31, 2026.

One video titled [REDACTED] depicted five different videos of extreme child pornography on a [REDACTED]. The video depicted a [REDACTED] child [REDACTED] being bound and hung with rope while being physically tortured and sexually battered. The child victim was physically beaten, hung upside down by [REDACTED] legs, burned with wax, and sexually battered in the video. The video accounted for five counts of possession of child pornography. Each segment was recorded at a different location.

Of the 24 instances of child pornography located on the device, 20 of the child victims were [REDACTED]. The other child victims were prepubescent [REDACTED] child victims being sexually battered and exposing their genitals in a lewd manner. An additional 14 instances of possession of child pornography were located on the device, from the counts he was arrested for on January 31, 2026.

Your Affiant located media files promoting pedophilia, child pornography, the rape of children, grooming of children, sex with children, the legalization of child pornography, and the normalization of pedophilia.

Your Affiant located a large quantity of files relating to extremist groups including 764, No Lives Matter (NLM), and Temple ov Blood. Media files promoted the groups. Files depicted subject matter relating to rape, Nazism, acts of violence, acts of terrorism, mass shootings, school shootings, self-harm / suicide, Satanism, harm to animals, and anti-religious groups directed towards Islam, Jewish, and Christianity. Files celebrated mass shootings and school shootings.

Your Affiant located media files depicting execution videos, shooting videos, mass shooting videos, animal mutilation, and necrophilia. One file depicted a subject engaged in sex with a [REDACTED] headless body.

Your Affiant located image files from the reported threats relating to Jose Pagan Jr on Telegram. The images included images of his father's firearms, and the black boiler suit with the NLM logo and skull facemask. The same skull facemask was observed from numerous images relating to No Lives Matter images and videos. The facemask appears to be a common piece of paraphernalia for the No Lives Matter group. Your Affiant located normal images of Jose Pagan Jr on the device.

Your Affiant located various Telegram chats involving No Lives Matter, Temple ov Blood, and Hate related groups.

Your Affiant located a Telegram chat from December 9, 2025, of evidentiary value. During the chat with another Telegram user, Jose Pagan Jr discussed planning and committing arson on two churches nearby his residence. The two discuss how to commit the offense and planning it out. The other user encourages the act. He has been considering targeting the churches for a long time. Jose Pagan Jr has been stalking a church. Per the context of the chat, it appears that Jose Pagan Jr sent a picture of a church to the other user, but the image is no longer available. Jose Pagan Jr texts that one church has an ADT security sticker and that concerns him. Jose Pagan Jr texts about test lighting gasoline at the home to confirm that the gasoline still lit. He advises he will bring more accelerants if the gasoline doesn't work. Jose Pagan Jr plans on setting the fire using clothing and paper. Jose Pagan Jr sent images of gasoline containers at his home. He utilized Google maps to see how long first responders would take to make it to the fire.

Your Affiant located another Telegram chat with user Rex from December 9, 2025, of evidentiary value. During the chat, Jose Pagan Jr made plans to burn down a church nearby his home. The two discuss how to commit the offense and planning it out. The other user encourages the act. He planned on setting fire to the church after 11PM when everyone is asleep to avoid being detected. Jose Pagan Jr discussed planning specific escape route and how to start the fire inside of the church by breaking a window. During the chat, Jose Pagan Jr texted his plan to also vandalize a home near his house that has a BLM (Black Lives Matter) flag. He wanted to vandalize the home by putting a swastika, "no lives matter," or a Temple ov Blood sigil on the home. During the chat, Jose Pagan Jr bragged about making a NLM patch out of paper and sent an image of the patch. The same patch is observed on images and videos of his black boiler suit.

Your Affiant located an additional Telegram chat with user Strauss from December 11, 2025, of evidentiary value. During the chat, Jose Pagan Jr discussed his plans to commit arson on a church. He bragged how it will be the biggest arson for NLMs. Jose Pagan Jr texted that he is going to video record the arson for NLMs notoriety. He wanted to record the arson on his iPad

to avoid being tracked/detected. The text messages continued on December 13 and 14, 2025. During the communications, Jose Pagan Jr specifically planned to commit the arson during the evening at 11:36 PM. He wanted to complete the arson at 1:36 AM but states he's too impatient. 136 is relating to white supremacy. At approximately 1141 to 1143 PM, he advised he is off schedule but is leaving for the church. At approximately 0247 AM, Jose Pagan Jr texted Strauss that the arson was a failure. He advised it took him an hour to walk to the church and when he arrived someone was at the church. He advised he hid the gas cans in his guitar case and now his case smells like gasoline.

Your Affiant reviewed the search history on the device. Your Affiant located searches for mass shooters/shootings and school shooters on the device to include the following names:

Nikolas Cruz
Patrick Crusius
James Huberty
Philip Manshaus

Your Affiant located searches for shootings in the Netherlands and searches for mass shootings, school shootings, and church attacks.

The defendant was identified verbally, his identity was confirmed via his father, and his HCSO booking photograph 2026-3521.
